Façade Improvement Micro Grant Program

The Downtown Development Authority (DDA) wishes to stimulate new investment, enhance business and development opportunities and to attract new customers to Downtown through a brighter and more attractive streetscape. The program is designed to increase customer traffic, enhance pedestrian safety, and improve the visual appeal of the street by providing an economic incentive to retailers, restaurants and other businesses for exterior and interior lighting which can be **seen from the front sidewalk and street.**

For interior (window display) and exterior lighting that enhances pedestrian safety in the public realm, a \$2,000 grant will be offered without requiring a match from the applicant, provided that the applicant keeps the lighting on from dusk until dawn.

Eligibility

Applications for grants shall meet the criteria outlined below:

1. Properties must be located within the downtown boundaries shown (See exhibit A)
2. The Lighting Improvement Micro Grant shall only be awarded for properties that contribute to the DDA through the payment of ad valorem taxes and are current on payment.
3. Applicants must be able to document total project costs that the grant amount will apply to.
4. Successful applicants must enter into a Funding/Grant Agreement with the DDA.
5. Prior to awarding of the check, there will be a final inspection of the installed lighting.

Application Process

Prospective applicant submits an application package which consists of an introductory letter providing an overview of the project and DDA Program Application.

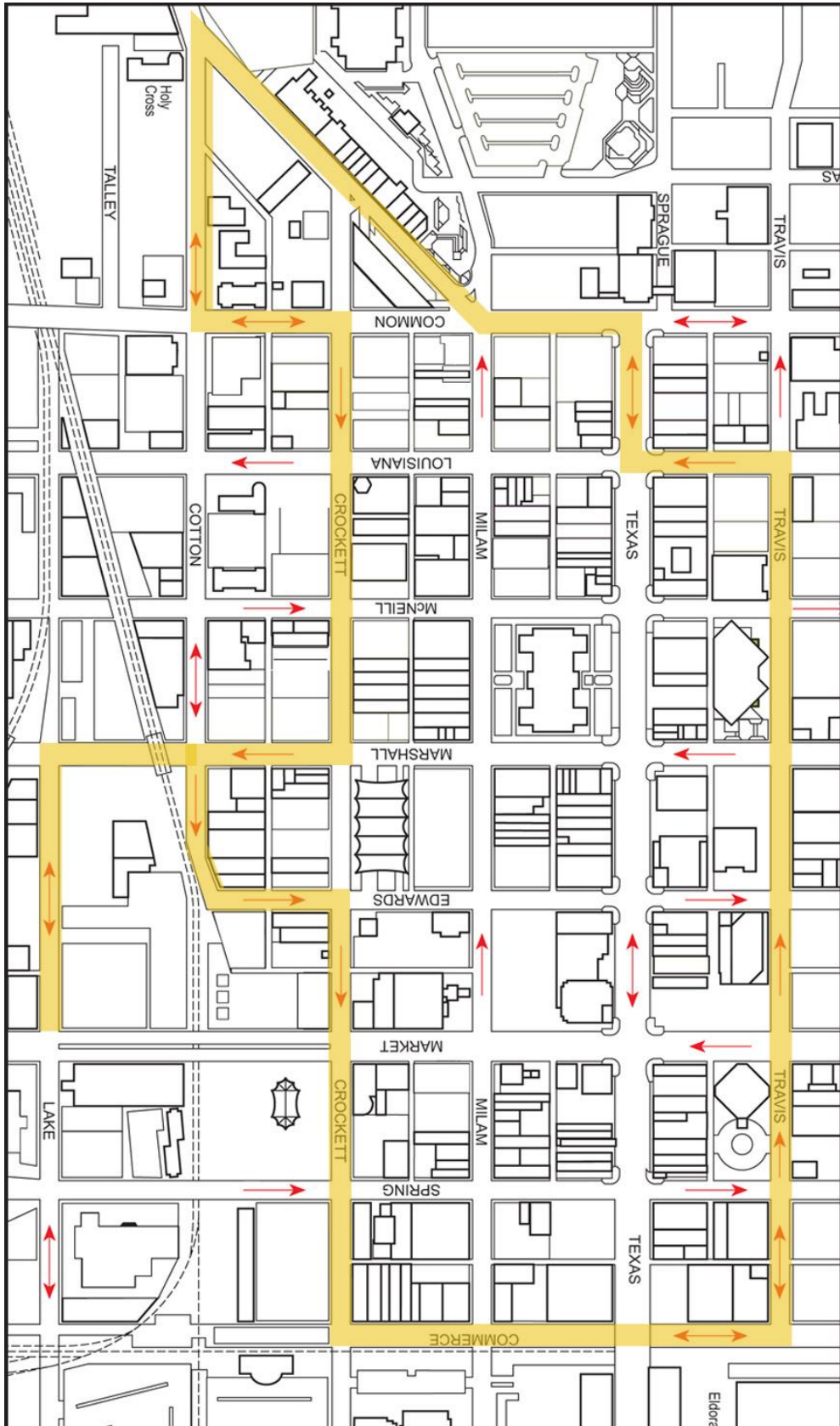
The DDA will provide a letter of Grant Commitment, subject to completion of the project according to city building permits, compliance with DDA program requirements, and all other required approvals. The Grant Commitment letter serves as a notice to proceed on Lighting Improvements.

The DDA grant pays only for lighting to be installed, not for lighting that already exists.

Disclosure

The DDA expressly reserves the right to reject any and all applications or to request additional information from any and all applicants and grantees. The DDA retains the right to deviate from the program guidelines, or amend the program guidelines, agreements, and application procedures. The DDAD also retains the right to display and advertise properties that receive funds under this Grant. Grant funds are limited.

Application For Downtown Lighting Grant Program

The DDA Downtown Lighting Grant is based on availability and considered on a first come first served basis. A completed application does not guarantee funding. Furthermore, no grants will be awarded retroactively, which means that funding will not be awarded for work done prior to the application date.

Applications will be reviewed and accepted as long as the required program guidelines have been met. Projects that do not comply with the program requirements and conditions will not be eligible for funding. An authorized corporate officer or partner(s) of the applicant's business must sign the application, in addition to the property owner(s), if the applicant is a tenant.
