# **DOWNTOWN DEVELOPMENT AUTHORITY SPONSORSHIP GUIDELINES**

The Downtown Development Authority (DDA) Board of Directors will consider offering sponsorship dollars to individuals/groups wishing to present events that are open to the public, promote development in the Downtown Development District (DDD), and are held in the DDD.

Preference will be given for a number of criteria such as history of performance and significant media coverage but also for those events that most closely align with the DDA's Mission Statement:

**To actively pursue, support, facilitate, and welcome initiatives that aid and encourage private development, and promote and coordinate public development within the Downtown Development District of Shreveport, La.**

In other words, how will this event or project help make downtown a more thriving place even after it is over?

The goal of our sponsorship is always to encourage events or projects in downtown Shreveport to highlight the history and culture of our urban core. **It cannot, under any circumstances, be used for fundraisers or political gatherings. If, in the opinion of the DDA Board of Directors, the sponsorship provided was used for a fundraiser or political gathering, the recipient shall be required to return the original sponsorship amount to the DDA.** Preference will be given to those public events that attract a diverse range of participation and promote development in Downtown Shreveport.

## **PROGRAM GUIDELINES:**

- 1. The event must be held in the Downtown Development District.**
- 2. Events can be fee-based or free but must be open to the public (cannot be used for events restricted to private or exclusive participation or for fundraisers or political activities).**
- 3. Existing events or projects adding enhancements can qualify.**
- 4. First-time events or programs can qualify.**
- 5. Sponsorships are awarded on a first-come, first-served basis provided DDA has sufficient funds to award.**
- 6. Grant applications will be judged on a number of criteria including:**
  - The amount of matching funding for the event**
  - Creativity of the event**
  - Potential impact of the event on the DDD**

- **Marketing of the event**
  - **Availability of DDA funds**
  - **Information provided in the application or by other means learned about the organization, organizers, and the event**
  - **The opinion of the DDA Board of Directors as to the fit of the event with the DDA Mission Statement**
7. **All required insurance and security must be provided by each event as mandated by the City of Shreveport / Shreveport Public Assembly and Recreation's Festival Task Force and/or Shreveport Police Department on road closures and other issues.**
  8. **Events must agree to use DDA logo on all materials and to link to the DDA website (if applicable). The DDA Marketing Manager will provide the approved DDA logo.**
  9. **Sponsorship Application must be completed and signed.**
  10. **The event must be listed in the Shreveport-Bossier Fun Guide.**
  11. **Organizer/Organization must provide any other information requested by DDA.**
  12. **Organizer/Organization is limited to one (1) DDA sponsorship per 12-month period.**
  13. **The sponsorship application must be received by the DDA board meeting that falls at least one (1) month prior to the event.**
